### 24/7 Travel Card Fuel Management Card Account Information

#### Pricing Option:

- 5¢ EFT Price Reduction off of the credit retail price of gas at any 24/7 Travel Store.
- 7¢ EFT Price Reduction off of the credit retail price of diesel at any 24/7 Travel Store.
- Up to an additional 7¢ per gallon discount, if weekly volume levels are met.
- 24/7 Travel Card fuel pricing and discounting is subject to change or cancellation with a 30 day written notice.
- Price on receipt will NOT match final pricing on invoice. All discounts on prices will be reflected on invoice only.

#### Fuel Tracking:

- Card Controls by Driver and/or Vehicle ID.
- Tracks miles driven.
- Track miles per gallon per vehicle when driver enters mileage.

#### 24/7 Account Requirements:

- Invoice emailed weekly, sorted by card number
- Weekly Electronic Funds Transfer (EFT).
- New Card fee is \$3.00 per card; Replacement card fee is \$3.00 per card.
- Monthly administration fee per company is \$10.00 per month.
- Must carry cards in vehicles or on driver.
- \$15.00 invoice inquiry surcharge

5¢ per gallon rebate discount	1-1499 gallons
6¢ per gallon rebate discount	1500-2499 gallons
7¢ per gallon rebate discount	2500 or more gallons

- C-Store Products can be restricted or allowed.
- Mix and match fuel and C-Store purchases by card.
